**USRC Kennel Registration Agreement:**

I am applying for USRC Kennel Registration

I will only breed Rottweilers who comply with the USRC standard for the Rottweiler. I will only breed Rottweilers who are at least 2 years of age. I will only breed Rottweilers who have been certified Free, HD +/-, HD A or HD B for hip dysplasia by OFA, or an FCI member kennel club or Rottweilers who have a valid USRC recognized Ztp. When docking, I will only dock tails on dogs less than 7 days old and will dock the entire litter. I understand that violation of this agreement is cause for revocation of my Kennel Registration and may result in the loss of USRC privileges which could include expulsion from the USRC.

**I agree** to the above USRC Breeding Regulations as a condition of my Kennel Registration.

**USRC Breeder Registration Agreement:**

I am applying for USRC Breeder Registration

I will only breed males or females that conform to the USRC Standard for the Rottweiler. I will only breed Rottweilers who have been certified Free, HD +/-, HD A or HD B for hip dysplasia by OFA, or an FCI member kennel club or Rottweilers who have a valid USRC recognized Ztp. When docking, I will only dock tails on dogs less than 7 days old and will dock the entire litter.

I will only breed females that are at least two years old and less than nine years old, and I will only breed males that are at least two years old and less than ten years old unless otherwise approved by the Breed Committee. I agree that my males will not breed more than two females per week, and not more than 40 females per year and my females will only have one litter per year unless otherwise approved by the Breed Committee.

I agree to register all future litters produced by a female owned or co-owned by me. I agree to only breed males or females with a USRC recognized breed test. I also agree to offer only male Rottweilers (owned or co-owned) at stud that have passed a USRC recognized breed test and only breed males to females that have passed a USRC recognized breed test.

I understand that violation of this agreement is cause for revocation of my Breeder Registration and may result in the loss of USRC privileges which could include expulsion from the USRC. I understand if there is a violation of the Breeder Registration rules or if I voluntarily request removal from the program, I may not re-enter the program for one year from the date of removal.
